CITY OF WINONA

AN ORDINANCE REGULATING TRANSIENT SOLICITORS, PEDDLERS, HAWKERS, ITINERANT MERCHANTS AND VENDORS OF MERCHANDISE IN THE CITY OF WINONA, MISSISSIPPI; DECLARING IT TO BE A NUISANCE FOR THESE ENGAGING IN SUCH PURSUITS TO GO IN OR UPON PRIVATE RESIDENCES, ETC., WITHOUT HAVING BEEN INVITED OR REQUESTED TO DO SO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF, ETC.

WHEREAS, The Mayor and Board of Aldermen of the City of Winona, Mississippi having maturely considered same, do find and determine that it is to the best interest of the City of Winona, and the residents thereof, that transient solicitors, peddlers, hawkers, itinerant merchants and vendors of merchandise should be regulated in the City of Winona, Mississippi.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF WINONA, MISSISSIPPI AS FOLLOWS, TO-WIT:

SECTION 1. That the practice of going in and upon private residences in the City of Winona, Mississippi, and other premises or establishments therein, by transient solicitors, peddlers, hawkers, itinerant merchants and vendors of merchandise not having been requested or invited to do so by the owner, owners, occupant or occupants of said private residence for the purpose of soliciting orders for the sale of goods, wares, and merchandise, and or disposing of or peddling or hawking the same, is declared to be a nuisance and punishable as such nuisance as a misdemeanor.

SECTION 2 That any person or persons violating the provisions of this ordinance shall, upon conviction thereof, be fined not more than \$200.00, or imprisoned not more than thirty (30) days, or both fined and imprisoned not in excess of thirty (30) days in the discretion of the court.

SECTION 3. That should any section or portion of any section or sections hereof be found and determined violative of any constitution section of laws by competent Court, such findings shall in no wise affect other sections or section hereof not found violative thereof.

SECTION 4. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 5. That the Clerk of the City of Winona, Mississippi be, and she is hereby directed to cause the publication of this Ordinance in a timely manner required by law and to obtain from the publisher of The Winona Times, a paper which said publication is to appear, a proof of publication reflects the said publication.

SECTION 6. That this Ordinance shall be in full force and effect in a timely manner required by law.

The above and foregoing Ordinance, having been first reduced to writing, was read and considered section by section, then as whole; the motion to adopt the foregoing Ordinance being made by Alderman Shelton, who was seconded by Alderman Austin, the vote section by section and a whole being as follows:


1. Section 1-6:

2. As a whole:


Alderman Charles L. Shelton voted	"Aye";


