**ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN
OF THE CITY OF WINONA, MISSISSIPPI TO GOVERN AND
RESTRICT PARKING ON CITY STREETS AND TO PROVIDE FOR
PENALTIES FOR THE VIOLATION THEREOF.**

WHEREAS, the Mayor and Board of Aldermen of the City of Winona, Montgomery County, Mississippi are authorized and granted full jurisdiction pursuant to Miss. Code Ann. Section 21-37-3 (1972) in matters involving the public streets and sidewalks of the City;

AND WHEREAS, the Mayor and Board of Aldermen find it necessary to enact an Ordinance regulating parking of motor vehicles, trailers, equipment or other obstructions on the public streets of the City, and to provide penalties for the violation of said Ordinance, for the abatement of the nuisance and hazards to the public safety caused by parking in certain areas of the city for the causes and reasons aforesaid.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF WINONA, MISSISSIPPI AS FOLLOWS:

Section 1. That the matters and facts found and adjudged in the preamble to this Ordinance be, and the same are hereby adopted herein.

Section 2. That effective in the time and manner prescribed by law, within the corporate limits of the City of Winona, Mississippi:

a) No person shall stop, stand or park a vehicle, as set out in *Miss. Code Ann. Section 63-3-901 et seq.* (1972);

b) any other street within the city that is located within ten (10) feet of a fire hydrant, marked with a curb painted red, or with a posted "No Parking" sign.

c) Before any such "No Parking" sign is posted adjacent to a city street, the Street Superintendent shall consult with the Chief of Police regarding the necessity of such a sign and notify the Mayor of the intention to place a sign on the designated street. The Mayor shall inform the Board of Aldermen of the intention to place the sign at the next regular meeting of the Mayor and Board of Aldermen who may override the decision if deemed appropriate.

Section 3. Penalties:

(a.) For a violation of this Ordinance, a violator may be fined in an amount not to exceed \$50.00.

Section 4. This Ordinance shall supplement any other Ordinance of the City of Winona and control to the extent it is in conflict with any other Ordinance concerning the parking on city streets within the corporate limits of the City of Winona, Mississippi.

Section 5. The City Clerk is authorized to publish this Ordinance in the Winona Times in the time and manner authorized by law.

The above and foregoing Ordinance having been first reduced to writing, was read and considered section by section and then as a whole, a motion to adopt the foregoing Ordinance being made by Alderman Johnson, duly seconded by Alderman Winbush, the vote section by section and then as a whole being as follows:

1. SECTIONS ONE - FIVE:




